
## Join Us in Guthrie on April 30, May 1-2, and Solve a Murder!

What better way to celebrate the birthday of one of England's best known Freemasons than to hold a "Murder Mystery" in the Sherlock Holmes tradition! The Guthrie Scottish Rite Spring Reunion, to be held on April 30, May 1-2, will honor Sir Arthur Conan Doyle, creator of one of the world's greatest, albeit, fictional, London detectives, the guintessential Sherlock Holmes. At the 2010 Sherlock Holmes Reunion, we will ponder over whether Holmes was a

Mason himself, outline which of the 52 Holmesian stories the Master Detective made reference to Freemasons; and even attempt to solve a murder which will occur in the temple sometime on Saturday of the Reunion.

Of course, it's all in great fun as we celebrate the 151st anniversary of the birth of Sir Arthur Conan Doyle, a name long synonymous with Sherlock Holmes. Dr. Doyle created the world's most famous detective in 1886, and joined the Masonic Lodge himself a year later, giving his curious and spiritual mind an opportunity to include Freemasons as characters in his stories. For example, Dr. James Watson, whose name has also been immortalized with Holmes, was a member of Doyle's own lodge. We'll uncover this, and other facets of Doyle's life, as we share together the feast of knowledge and fraternity during our big "Sherlock Holmes" Reunion.

As many members know, this is the only chance Master Masons and Scottish Rite Members will have this year to see all 29 Degrees of the Rite performed on the stage of the great auditorium in the Guthrie Temple. tion to the Scottish Rite sponsored by our Valley's new member mentorship group. This will be a chance for candidates to ask questions, get acquainted with each other, and become immediately engaged in the reunion experience before it officially begins.

The work on Friday will start at 8:45 am with an introduction to the Lodge of Perfection Degrees. Work will continue throughout the day. Following the 15°, the Valley will host a reception in the Atrium honoring our new Deputy in Oklahoma, III. Joe R. Manning, Jr. Dinner will follow in the Legislative Hall at 6:30 pm. The Knights of St. Andrews will then conduct their impressive "processional of knights" in the beautiful Temple Atrium. All brethren and their ladies are welcome to observe this very fraternal and knightly gathering of our younger Scottish Rite men. We will then all retire to the Egyptian Room to watch a classic Sherlock Holmes movie, starring our favorite Holmes detective of all time, Basil Rathbone. The Mentorship committee will also create a scavenger hunt for the candidates, and there will be opportunities to more fully explore a degree of the Rite in a shared dialogue with our candidates.

On Saturday, following a hearty breakfast in the Temple Café, the Degree teams of the Valley will confer the 16° through the 26°. There will be temple tours and coffees arranged for our ladies during the day. On Saturday evening, a banquet will be held in the Legislative Hall, after which a Murder Mystery will unfold. The "who done it" will be decided by YOU, our Reunion attendees! You won't want to miss the fun of a good old fashion Holmes mystery; and, who knows, YOU may be the one who solves the crime! A special prize will be given the individual/team that solves the mystery!

On Sunday morning, the work will begin at 7:30 am with the conferral of the 27°. The Reunion should conclude around 4 pm on Sunday afternoon, May 2.

The Guthrie Valley invites all 32° Masons to attend and enjoy the work of the Scottish Rite on the first weekend in May. If it's been awhile since you have attended a Reunion, all you need is your current year's dues card. It will be a wonderful time to get re-acquainted with Oklahoma's most beautiful building; and Freemasonry's college course in Masonic teaching.

## MANNING APPOINTED DEPUTY IN OKLAHOMA

With the retirement this past December of III. Joseph C. Jennings, 33°, as Oklahoma's only Active Member on the Supreme Council, the leadership of the Scottish Rite in our Orient has been assigned to III. Joe R. Manning, Jr., 33°, by the Southern Jurisdiction's Sovereign Grand Commander, Ronnie Seale. Brother Manning takes on the responsibility as chief executive officer of the Scottish Rite in Oklahoma and will be responsible to the Supreme Council for the activities of Scottish Rite Masonry in the Sooner state.

Brother Manning is imminently qualified to assume this important position on behalf of the members of the Scottish Rite in the three Oklahoma Valleys. He has served as Personal Representative to Brother Jennings in the Valley of Guthrie and Chairman of the



Guthrie Advisory Conference since 2003. He was appointed to the Guthrie Advisory Conference in 1991. Moreover, his active involvement in the fraternity extends far beyond the Rite. He has distinguished himself in all branches of Masonry. Freemasonry has been a way of life for our new Deputy.

Brother Manning served the Grand Lodge of Oklahoma as its Grand Master in 1985. He currently serves as its Grand Representative to the Grand Lodge of England. He is a member and Past Master of Cushing Lodge No. 111, a Past High Priest, Past Illustrious Master, and Past Commander of the York Rite Bodies, and holds the Knight York Cross of Honor in Oklahoma Priory No. 9. He is a charter member, Past Governor, and Past Grand Governor of the Oklahoma York Rite College, and will be installed as the Head of the York Rite Sovereign College of North America later this year. He is also a Past Preceptor of the Holy Royal Arch Knight Templar Priests in Oklahoma and is currently serving as the Grand Preceptor of this Body nationally. He is a Past Grand Sovereign of the Red Cross of Constantine for the United States, Mexico, and the Philippines.

In addition, Deputy Manning is a Past Master of the Great Chief's Council of the Allied Masonic Degrees in Washington, D.C. and serves as an officer in the Grand Council, AMD of the United States. He is the Chief Adept of the Society of Masonic Rosicrucians in Oklahoma. He is a member of the Knight Masons of the USA; the Grand College of Rites; Order of St. Thomas of Acon, Great Priory of America, CBCS; Tall Cedars of Lebanon, India Temple Shrine, Sabba Grotto, the Royal Order of Scotland, the National Sojourners, and Heroes of '76.

Our new Deputy has also committed his life to the Order of DeMolay, serving as a Past State Master Councilor, Past Grand Master, Grand Secretary, and Active Member of the International Supreme Council, as well as being President of the Oklahoma DeMolay Trust, and Past Executive Officer in Oklahoma. He holds the Grand Cross of Colors in Rainbow.

Brother Manning is a lifelong resident of Cushing. He earned a Bachelor of Arts Degree from Oklahoma State University in 1969 and a Juris Doctor Degree from the University of Oklahoma College of Law in 1973. He worked as the Business Manager and Executive Director of the Oklahoma Masonic Charity Foundation, retiring in 2008 after 26 years of service to the charities of Masonry in Oklahoma.

Our Deputy served as a member of the Oklahoma House of Representatives in the 35th through the 38th Legislatures from 1974 to 1982. He served the Governor of Oklahoma as a Senior Member of his staff from 1987 through 1989. He is a Past Chairman of the Oklahoma Department of Corrections and Past President of the Governing Board of Prevent Blindness Oklahoma. Brother Manning has been a long time member of the Cushing City Council, having served as Mayor for eight years, and is the current Vice-Mayor. He is also the Vice-chairman of the Cushing Regional Hospital.

We wish our Deputy many years of success as he takes on the leadership of the Rite in Oklahoma. He is accustomed to leadership. We are proud of his commitment to Masonry, and look forward to seeing him and his wife Cindy at the Reunions of the three Valleys for many years to come.



Like it or not, the pure size of our Masonic buildings, the investment we have in regalia and properties, and the management of our large member pools necessitates a certain amount of revenue be secured every year. That revenue can only come from members. And it must also be shared between the Valley and its national headquarters. This makes member retention a leadership issue. Member retention is just another way of categorizing member satisfaction. It really does come down to the value each member places in his Scottish Rite membership.

This is why the theme of this year's national leadership conference of the Scottish Rite is titled "Membership through Leadership." It boils down to reinforcing awareness that our members are the single most important element of our organization, and their contentment with the Rite ultimately determines their tenure.

The 2010 Scottish Rite Leadership Conference will be held at the Sheraton New Orleans hotel on April 16–17. The conference will examine how active leadership can be employed to stem the tide of membership losses at the Valley level. It will explore how leadership directly affects membership. And the conference promises to bring forward a new slate of programs each specifically designed to put real world tools into the hands of today's Scottish Rite leaders—Rite Now!

The Oklahoma Valley Secretaries and Board Chairmen will attend the conference, and look forward to bringing ideas back that can be shared with our local Membership teams. It is an important leadership imperative that every member feel a sense of enjoyment and commitment to the Rite, even if he is unable personally to be involved with meetings, travel, and regular associations with his fraternal fellows. There are different ways to be satisfied with the organizations in which one spends his life. From a leadership perspective, it is essential that these ways be communicated effectively to every member—Rite Now.
